What do we provide?

Befriending: we operate two national schemes that provide home visits and/or regular calls to those experiencing loneliness and social isolation





Local Community Groups:

offering a forum for friendship within towns and villages across the country. Dependent on size the groups offer everything from visiting speakers to day trips/holidays.

How can you help?
