In the Civil Service, I worked in a range of departments, from the centre of government, as Principal Private Secretary to the Cabinet Secretary, to Director General of Environment, Rural and Marine in Defra. I've seen the important contribution civil servants make in their diverse roles – and the stresses they experience.

TOM'S STORY


Tom struggled with financial hardship when his daughter, Sophie, was diagnosed with epilepsy aged two.

Patricia and Peter met working for what was then the Customs and Excise Department. They married and baby Elizabeth was born. A few years later Peter died suddenly, leaving Patricia with no income to support herself and her daughter. Thankfully, she was able to turn to the Charity for Civil Servants. We provided Patricia with financial assistance and support through one of the most challenging times of her life.

Patricia never forgot the difference that help made as she remembered the Charity in her Will:
